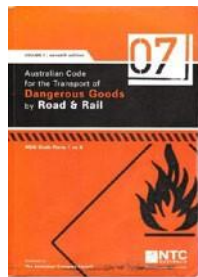
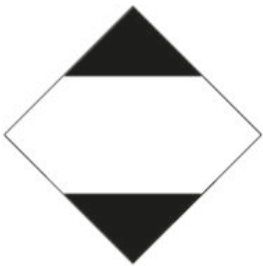


Finding it hard to make head or tail of aerosol regulations?
