The Aerosol Industry Awards are now open for entries!

Don't miss your chance to help celebrate excellence and innovation in the aerosol industry and to achieve recognition for your team / brand / product.

CATEGORIES

The Aerosol Industry Awards include five categories:

1. Award for Sustainability
2. Award for Process Safety or Training
3. Award For Innovation – Product (Application) or Process
4. Award For Innovation – Packaging
5. 'Aerosol Product of the Year'

Please note that the Awards are open to aerosol fillers, marketers and suppliers to the sector. For more details, see 'Conditions of Entry' below.

AWARD FOR SUSTAINABILITY

This Award will be presented to a company which has demonstrated sustainable benefits associated with their products or their manufacturing and distribution processes in one or more of the aspects of social, economic, environmental or human relations.

AWARD FOR PROCESS SAFETY OR TRAINING

This Award will be presented to a company which demonstrates innovation and excellence in its training processes and systems. This is an opportunity to highlight training and HR initiatives which have delivered tangible benefits in terms of staff involvement / empowerment, safety and manufacturing productivity.

AWARD FOR INNOVATION - PRODUCT (APPLICATION) OR PROCESS

This Award recognises the achievement of companies who demonstrate innovation in their approach to product design, manufacturing or systems technology and apply it to their (aerosol) products or manufacturing and distribution processes in new and innovative ways.

AWARD FOR INNOVATION - PACKAGING

This Award recognizes those achievements in aerosol package design which increase the appeal of the product to the consumer. Such achievements may include (but shall not be limited to) the innovative use of can / actuator / valve / branding or printing processes or the combination of these.

'AEROSOL PRODUCT OF THE YEAR'

This Award is aimed at recognising that 'stand out' product which champions the potential and appeal of the aerosol package.

All product entries in the above categories are automatically entered in this category.

CONDITIONS OF ENTRY

1. Products must be manufactured for or by a company that is a current financial member of either the Aerosol Association of Australia Inc. or the Aerosol Association of New Zealand (Inc.) and be freely available on the market in Australasia or overseas or be committed to distribution on it on or before 1 July 2021.
2. All entries must be made using the official Entry Form and **must include a one page Executive Summary and a detailed submission which addresses all criteria in the relevant award category. Five (5) samples of each product entry must be provided to assist in judging.**
3. Product entries must be submitted in the name of the vendor (marketer or brand owner) and unless the entrant, the brand owner must consent to the entry being submitted and have confirmed all details stated on the Entry Form. Entrants should provide with their entry a report on their involvement in the work submitted, including any technical specifications, plans, photographs and diagrams which may assist the judging.
All participating parties should be acknowledged (e.g. outside designers etc).
4. Products entered may be submitted for more than one category. The Organisers reserve the right to re-allocate an entry to a more suitable category and/or to place entries in more than one category.
5. The Awards will be made on the basis of information provided by entrants. The Organisers accept no responsibility for inaccurate or misleading information issued when using this information.
The Awards do not constitute an endorsement or approval of a product, container, valve, or any part of the package, nor do they constitute a determination that the packaging or labelling meets any National, State or Federal Laws or Regulations.
6. No correspondence will be entered into regarding the judges' decisions and their decisions will be final.
7. All product entries remain the property of the Organisers unless specific arrangements are made beforehand for their return.
The Organisers may without further correspondence use these entries for promotional purposes.
8. It is the responsibility of the entrant, if desired, to protect any aspects of the entry by copyright or applicable patents.
9. It is the responsibility of entrants to ensure that their entries and supporting information arrive on time and in good condition. The Organisers accept no responsibility for entries which arrive late or damaged. All entries will be kept under secure conditions however the organisers accept no responsibility for loss or damage. All entries of value should be insured by the entrant.
10. The closing date for submission of entries is **5:00 PM on 15 OCTOBER 2021.**

Winners will be announced at the Gala Awards Dinner in Sydney, Australia on 16 NOVEMBER 2021.
