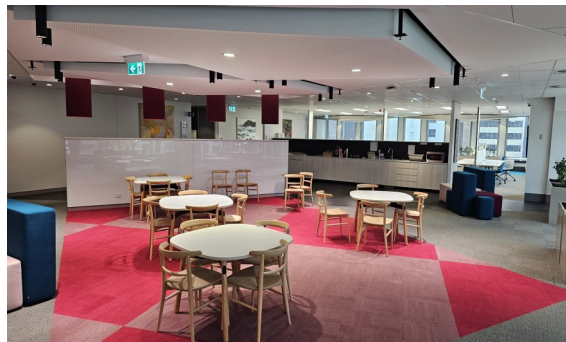
Make sure you don't miss this unique opportunity as we address questions like:
